- Is there a meter on the pool? It looks like it is running too much. Angela asked Russ if the water meter usage elevated? Russ replied that it is on the sprinkler meter and it is not elevated. It was elevated when the pool guy drained the pool.
- 5. Did my building use too much water? Russ replied that the C Building usage was high.
- 6. Will Nancy take the responsibility for the landscapers? It seems like they are destroying the landscaping. There have been lots of problems back from 2016 and 2014. Nancy replied she was meeting with Richmond Landscaping and would discuss his concerns.

After Mark left the meeting, Jan brought up the lack of photinia which caused a hole in front of her condo and that the back of the W Building looks bad.

The Dues increase caused an increase in savings account
