## **Management Report:**

### Annual Meeting-

The annual meeting was held on May 24, 2016 at the Harrington Library. It was well attended. Kathleen Savage was re-elected as Vice President.

## **Buildings/Gutters-**

The front area of A-6 was sprayed to remove hornets and bees. Chaparral Pest Control did spot treatments for fire ants at G-9. A birds nest was removed from A-6. Gutters were repaired at units J-4, B-5, B-6, O-3, Q-1, and M-4. Leaf guards were installed on J-4 and W-4. The gutters at buildings W and S were cleaned.

### Carpentry-

The trim around the top of the front doors of units E-2, F-3, and P-2 were repaired/replaced. A window leak was repaired and painted at K-1. Sheet rock repair was finished at G-2 and J-4. The soffit was repaired at O-3.

### Lighting-

The bulbs were replaced in lights at buildings K and W. A new light was installed at the L building. A flood light was replaced at the W building. A light fixture was replaced on the back side of the gazebo. A new flood light will be added onto the pool house to light up the pool at night.

# Fencing/Pool/Gazebo-

The fence at the V building dumpster was repaired and a new slat was put in at V-11. All Aquatic Pool Service installed new deck tile markers. S & B Gateworks installed a new lock on the pool gate.

The rosin on the gazebo floor is wearing off. Excel will get an estimate to repair it.

## Landscaping/Roofing-

Richmond did irrigation repair at K-1. Martin removed a dead Juniper tree at V-2, dead shrubs at T-3 and J-3, and removed the bamboo in the creek area.

Due to the storms, Evans & Horton did roof repairs on Bldg. A, K-3, S-3, O-1, O-3, Q-4, V-10, and V-11.

#### **General Discussion:**

There is a CD coming up for renewal on June 22, 2016. The board discussed whether to leave it to roll over or move it to the Money Market account.
