Bids/Carpentry/Fencing-

Driveway/ Roofing/ Plumbing-

Evans & Horton began the roof replacements with building W.

A plumbing inspection was done one the I building due to high water usage.

Exterior Lighting/ Electrical

Dallas Electric removed a damaged pole behind building I and replaced a defective light socket & ballast between U and V.

Oncor replaced the transformer box at the V building. Martin rehung the electrical box at W-2.

The board discussed where more lighting was needed.

Russell- I make a motion to put a new light at the gazebo.

Gutters/ Landscaping/Painting-

The loose gutters at W-4 were secured.

Sprinklers/Painting/ Retaining Wall-

Richmond replaced two broken rotor heads behind the mail center and a valve behind S-4.
